## DUTCH OVEN APPLE CARAMEL COBLER

Submitted by Susan Erlandson

8-10 lrg Granny Smith apples, peeled, cored & sliced  
 2 T lemon juice  
 2/3 c sugar  
 2/3 c flour  
 1 T cinnamon  
 3/4 tsp nutmeg  
 1/4 tsp cloves  
 3/4 tsp salt  
 1 (12 oz) jar caramel sauce  
 2 c brown sugar  
 2 c flour  
 1 1/2 c instant oatmeal  
 1/2 c chopped nuts  
 1 c melted butter



Add apples and lemon juice to a buttered Dutch oven and stir to coat. In a separate dish combine sugar, flour, cinnamon, nutmeg, cloves and salt; mix well. Pour the dry ingredient mix over the apples and stir until the apples are well coated. Pour the caramel sauce over the top.

In a separate bowl, combine the brown sugar, flour, oatmeal and nuts and stir. Use a fork to mix in the melted butter to form coarse crumbs. Spread this topping over the apples. Cover the Dutch oven and bake, using 10-12 briquettes on the bottom and 16-18 briquettes on the top for 60 minutes.






