

The plant species found there, including seven rare plants, occurs nowhere else in the world. The week before we had talked to a BLM employee who was looking for areas to put up cameras to view the pigs. He informed us that, with the proper tags, it is legal to hunt them. So here is a chance for you to hunt that is close to home. Just don't do it New Year's Day!

Lessons Learned

Sunday, Dec 10, was the long-awaited Columbia All Equestrian Christmas Parade. I have been looking forward to this parade, and preparing for this parade, for the past year. The day comes, Montana, my bay roan, is all decorated in his Christmas decor. We mount up and ride to the staging area. There's the usual pre-parade chaos: people trying to figure out where to be and which way to go. As we were standing around on our horses waiting for our next direction, Montana was nice and calm, not phased by the commotions surrounding us. We were then instructed to clear the road to let Santa's carriage pass. This beautiful carriage, pulled by two beautiful, white Percheron horses, all decked out with shiny bells and glitter, with Santa and Mrs. Claus in the passenger seat. We proceeded to the side of the road, making room for the carriage to drive by. Initially, I noticed my horse was nervous, but not unruly. That quickly escalated! By this time the carriage was halfway by, with all the jingling, the shimmering, the clip-clops of the horses and all the other loud noises this rig made. Well, that became way too much for Montana to handle! He wanted out of there and nothing was going to stop him! He barrels through the other horses (later, his actions were described as looking like a dolphin jumping out of the water!), and before I knew it...Bam! I hit the hard pavement! Now I forgot to mention, Sunday, December 10 also happened to be my 50th birthday. So here I am, at age 50, with fall #? (I really have lost count!). I lay there on the ground, and as with all previous, unplanned dismounts, I quickly evaluated myself. I am alive! Conscious! What hurts? Anything really hurt? This time my head did hit the pavement, so I had to evaluate that impact. I decided, as I heard friends and fellow riders advising me to stay down, take it slow. Are you dizzy? I decided I am fine, sore, embarrassed and mad, but fine! Then I got up, with some assistance, to find my horse. He had been safely captured by friends. I proceeded, as always, to get right back on. Which I did, but his anxiety was still high, and so was mine. I made the tough, unwanted decision of walking my horse through the parade! This parade I was so looking forward to. Saying I was disappointed is an understatement!

I was encouraged to write my story and say what I have learned from this incident. What have I learned here? Have I learned anything? I suppose I have learned wearing a helmet is important, especially while

riding in a potentially high anxiety situation, and on pavement! I was fortunate to only come out with a minor bump on my head. Also, I learned I need to find a way to teach this 50 year old body to mount my horse from the ground. While that may not have necessarily helped this situation, it may have helped my decision to get down in a high anxiety situation rather than think "if I get down, where or how will I get back up?" And I have learned horseback riding sure takes a certain level of grit, certainly the unplanned dismount parts! So I suppose that should make me somewhat proud that I do have that going for me. And I will NOT take the next carriage siting for granted!

Merry Christmas and Happy New Year to you all!




